## **Instructions for Completing General Application for Membership Form**

All applications for membership, regardless of class, may be considered at any regularly scheduled or special meeting of the Board of Directors. All required application and/or membership fees must be paid in full prior to final approval of application. All information required per membership class must accompany the original application for membership. Initial application fees associated with the individual membership classes are non-refundable.

All applicants must complete Sections A and B of the application form.

**Section C.** All applicants for Chapter Affiliate membership status must complete Section C of the General Application for Membership form. In addition, applicants must submit the following information separately with the application:

- Copy of organization's Articles of Incorporation as filed with their state regulatory body
- Copy of organization's Constitution/Bylaws
- Copy of organizations Non-profit Tax Exemption certification letter from IRS
- Contact information for not less than 3 of organizations general officers
- Summary of organizations principal activities or programs in which they participate within the community
- Letter requesting chapter affiliation status on organizational letterhead, signed by President. All requested information which is not available should be explained in this letter
- Certified check or money order in the amount of the initial application fee

**Section D.** All applicants for Individual Membership status must complete Section D of the General Application for Membership form. In addition, applicants must submit the following information separately with the application:

- Copy of law enforcement agency identification
- Letter requesting individual membership status, signed by the applicant. Letter should additionally summarize applicants activities in the community and certify that there is no established active or functioning local chapter affiliate within a 25 mile radius of either the applicants residence or place of employment

**Applicants for Associate Membership.** All applicants for Associate Membership status must complete both Section A and B of the General Application for Membership form. In addition, applicants must submit the following information separately with the application:

- Letter requesting Associate Membership status, signed by the applicant. Letter should additionally summarize applicants activities in the community

**Applicants for Corporate Membership.** All applicants for Corporate Membership status must complete both Section A and B of the General Application for Membership form. In addition, applicants must submit the following information separately with the application:

- Letter requesting Corporate Membership status, signed by an officer of the corporation. Letter should additionally summarize the corporations organizational focus, as well as activities engaged in providing direct or indirect assistance to low-income and communities of color
